SITUATION

Current Situation:	<p>Redwood Valley incident: The fire is backing into the Eel River drainage near Van Arsdale . The fire will continue to burn N and E toward Pine Mountain and N and W towards Tomki Rd. There are approximately 2,000 evacuees affected by the Redwood incident.</p> <p>Sulphur incident: Crews will continue to mop up and patrol, fire suppression repair is expected to begin on Monday 10/16/17.</p>
Evacuation Orders:	<p>REDWOOD FIRE: <u>Redwood Valley:</u> West Road North of Laughlin Way, East Rd North of Held Road. Bakers Creek Road north of Laughlin Way.</p> <p><u>Potter Valley:</u> Eel River Rd North of the Stroh Ranch. Van Arsdale area north of Eel River; Cave Creek subdivision including scenic Appaloosa and including all feeder roads; Van Arsdale road south of the Eel River.</p> <p><u>Pine Mountain:</u></p>

All feeder roads to the north and south of Ridgewood Rd (Pine Mountain subdivision) and Bear Canyon Road; Canyon Rd to Eastside Rd south to Pine Mountain Rd.</p>	
<p>Evacuation Warning:</p>	<p>REDWOOD FIRE: <u>Redwood Valley community south of the following:</u> -West Road south of and including Laughlin Way -Road I to Colony Drive (including Madrone Lane) -West of Ricetti Lane at entrance to Black Bart Trail -East Hill Rd @ HWY 101 bypass to the east to East Side Rd -Ridgewood Rd south to Howard Forest -Redwood Ave including Redwood Valley Rancheria</p> <p>-Laughlin Way south of Bakers Creek -East Road south of Held Road -East of US-101 -North of Highway 20 -West of the intersection of East Hill Rd</p> <p><u>Potter Valley:</u> -Eel River Rd south of the Stroh Ranch -Hawn Creek Rd -Westside Potter Valley Rd -Potter Valley Rd from HWY 20 to Main St (excluding Shale Ln) -Remainder of Potter Valley west of the Lake County Line</p> <p>-Powerhouse Rd -Gibson Ln east of Hawn Creek Rd -Main St east of Hawn Creek -Spring Valley Rd</p> <p>Residents returning to the fire area should exercise extreme caution. Fire, Law Enforcement, and utility crews continue to work in the area, as there are many downed trees and other hazards. As these areas remain under an EVACUATION WARNING, residents should be prepared to evacuate again on short notice.</p>
