

## Smoke Outlook for 8/13 - 8/14 NW California - Red Salmon Complex



## Fire

Fire activity moderated last night and is expected to pick up this afternoon with warm and sunny weather. A warming trend is forecast for the weekend, which is expected to increase fire activity. Detailed fire information can be found at: https://inciweb.nwcg.gov/incident/6891

## **Smoke**

Smoke impacts continue to be in the Unhealthy level at Forks of Salmon and areas close to the fire. Communities down drainage along the Bigfoot Highway will again see elevated smoke mix down to the surface midday. This will degrade air quality in areas such as Orleans, Weitchpec and Hoopa, which could see periods of Unhealthy air at times. Areas east of the fire, including Etna and the Scott Valley, should again see smoke impacts rise to Unhealthy late in the day before improving in the overnight and morning hours. Generally west to northwest transport winds should keep the skies hazy over Shasta Valley and areas far to the east and southeast of the fire.

Air Quality Index (AQI)	Actions to Protect Yourself
